Subscription or redemption orders in the Sicav must reach JP Morgan Bank Luxembourg SA (JP Morgan), every bank business day in Luxembourg before the cut off time (Luxembourg time) defined for each sub-fund.



Once your subscription or redemption order reaches JP Morgan and is accepted by them, you will be entitled to the following business day's NAV (valuation date). Payment (settlement date) are due no later than three business days following the trade date. Transaction details and payment instructions will be confirmed to you or your bank by JP Morgan on a contract note.

The Net Asset Value (NAV) is calculated each business day based on the previous day's market closing prices.
