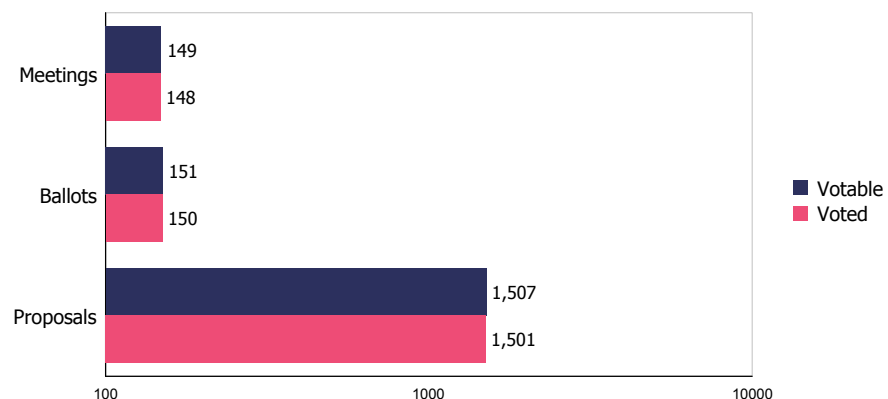

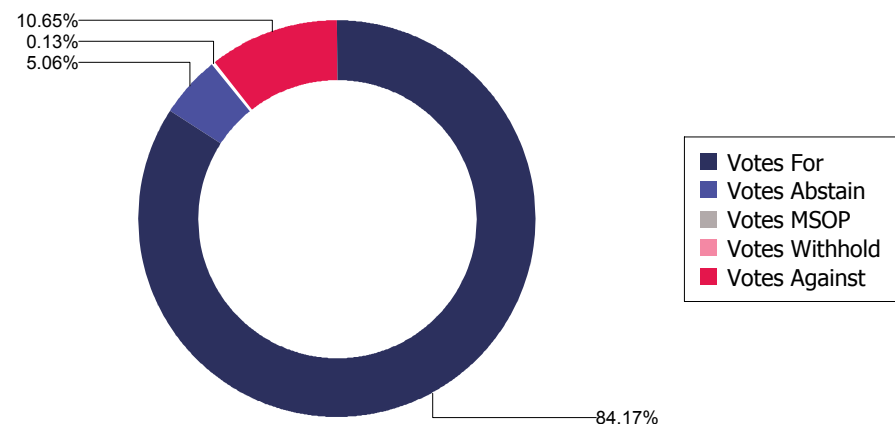

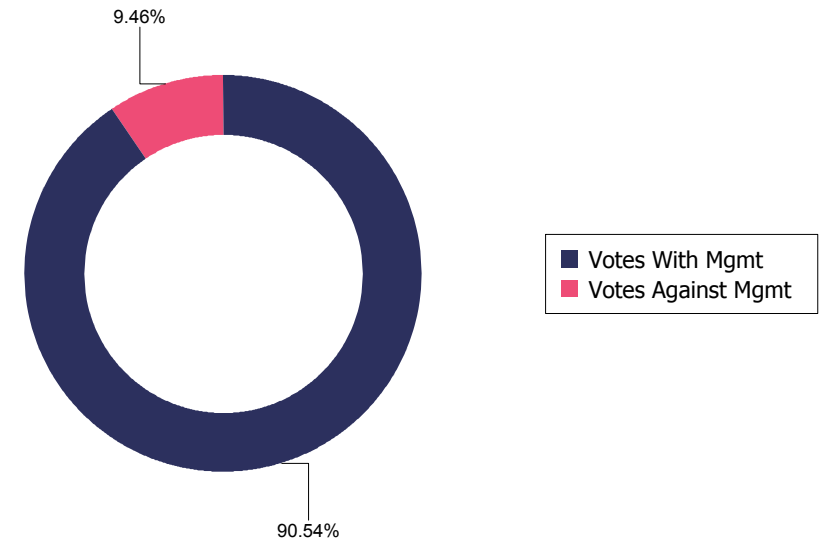
Vote Cast Statistics

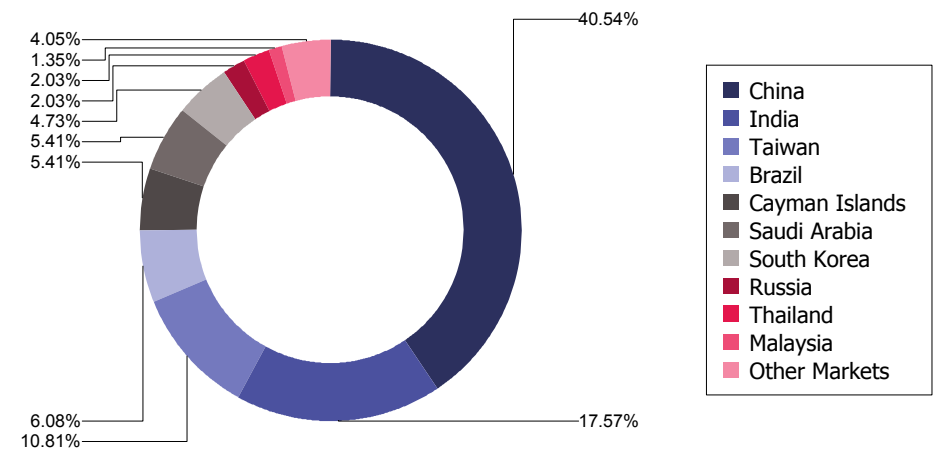
Vote Alignment with Management



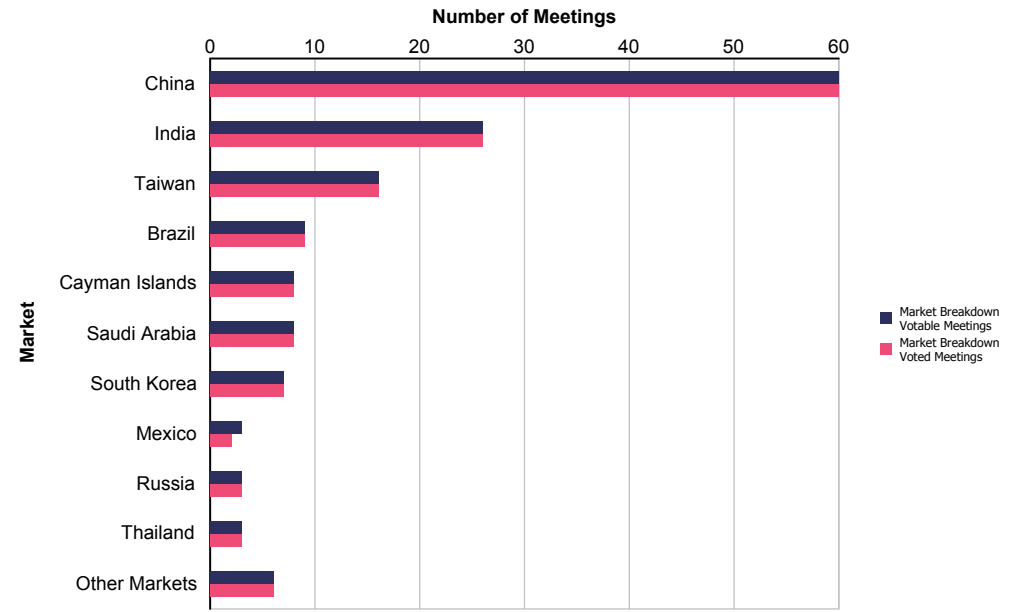
